The Aarhus Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters<sup>2</sup> ('the Aarhus Convention') establishes that, in certain cases, natural and legal persons (such as non-governmental organisations, 'NGOs') can bring a case to a court or to other impartial bodies in order to allow for the review of acts or omissions of public or private bodies<sup>3</sup>.

A Communication Intermediary (CI) assists people with speech and language disabilities to understand questions and to communicate answers effectively when communicating with police, legal or justice professionals. CIs assist victims, witnesses and accused to give complete, accurate and authentic evidence in all phases of the justice system.

Communication Intermediaries - Access to Justice

People who have communication disabilities may experience one or more of the following barriers when accessing the justice system. They may: Not have ways to communicate what happened; Not be able to communicate with police or justice professionals using communication methods other than speech; Not understand questions posed to them
