Oftentimes it's as simple as making a statement under oath to get yourself a new certified copy of your lost document. The courts have to make sure you really lost it ...

Free Affidavit of Lost Document | Free to Print, Save ...

This document should be completed by a person, known as the Affiant, who can attest under oath of their personal knowledge of the circumstances of the loss of the object. The Affiant is usually the owner of the lost object, especially if the affidavit is going to be used to support an application for a replacement of the lost object. The document includes identifying information of the Affiant, including their name, citizenship, age, and address.

The Concur system allows for a Missing Receipt Affidavit to be completed within the system replacing the formerly used paper form. Employees should always first contact the vendor to obtain a duplicate copy of the lost or misplaced documentation.

In the event of a missing airline receipt (last page of the ticket stub), the affidavit must be accompanied by some form of documentation. The agency issuing the original ticket must be contacted and a copy of the receipt requested. All agencies are required by the Airline Reporting Commission to keep copies of every ticket they issue.
