Chapter in an edited book, reprinted from another book; Use the same formats for both print and ebook edited book chapters. For ebook chapters, the format, platform, or device (e.g., Kindle) is not included in the reference. Do not create references for chapters of authored books. Instead, write a reference for the whole authored book and cite the chapter in the text if desired.

Chapter in an Edited Book/Ebook References - APA Style

To cite a chapter in a book in a reference entry in APA style 7th edition include the following elements: Author (s) of the chapter: Give the last name and initials (e. g. Watson, J. D.) of up to 20 authors with the last name preceded by an ampersand (&). For 21 or more authors include the first 19 names followed by an ellipsis (...) and add the last author's name.

Structure: Author Last Name, First Initial. Middle Initial. (Year Published).

Edited book chapters. An edited book is a book in which different people have written different chapters, and the chapters have been compiled or put together by an editor. If you used information from just one chapter of an edited book, cite the chapter you used in the reference list. Create separate reference list entries for separate edited book chapters that you used.

To create a reference for a chapter in an edited book, follow the example for a chapter in an edited book without a DOI. At the end of the reference,

An edited book is where each chapter is by different author (s), and an editor (s) pulls them together and perhaps writes an introduction. You must cite/reference the individual chapter you used, rather than the book as a whole (it is possible you would cite and reference a number of chapters separately that are from the same edited book).

Chapters in edited books: When citing a chapter in an edited book, use the following format: Structure for chapters in edited books in print: Last name of chapter author, First initial. Middle initial. (Year published). Chapter title. In First initial. Middle initial. Last name of Editor (Ed.), Book title (pp. xx-xx). Publisher. Example: De Abreu, B.S. (2001).

In this case, you should give the chapter author's surname and the year of publication for the edited volume in citations. In the reference list, meanwhile, the entry for a chapter from an edited book requires the following information: Author's Surname, INITIAL(S). (Year). Chapter title. In Editor's Name (Ed.), Book title: Subtitle (page range). Publisher.

Basic book citation format The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).
