The APA style calls for three kinds of information to be included in in-text citations. The author's last name and the work's date of publication must always appear, and these items must match exactly the corresponding entry in the references list. The third kind of information, the page number, appears only in a citation to a direct quotation.

When there is no author your in-text and parenthetical citations should begin with the first couple words of the title and include the year of publication. When citing books, videos, brochures, journals, reports, etc. italicize the title. When citing web pages, journal article titles, or chapter titles use quotation marks around the title.

The APA citation style (6th Edition) is a parenthetical author-date style, so you need to put the author's last name and the publishing date into parentheses wherever another source is used in the narrative. The APA format consists of in-text citations and a reference list, along with guidelines for formatting the paper itself.

Citations are placed in the context of discussion using the author's last name and date of publication. When a work has no identified author, cite in text the first few words of the article title using double quotation marks, "headline- style" capitalization, and the year. ("Barcelona to Ban Burqa," 2010)
