Summary. SOCIAL JUSTICE. The first section of A Theory of Justice is called "The Role of Justice," and it begins with a bold assertion of the centrality of the virtue of justice: "Justice is the first virtue of social institutions, as truth is of systems of thought.". (TJ, 3/3) The claim is that while there may be other virtues of social institutions, they may not be achieved by sacrificing justice.

In Chapter 1 Rawls establishes the grounds against which he will develop and argue for his theory of justice. He does this by reflecting on the nature and importance of justice and moral theory in general; contextualizing the discussion within a web of basic concepts and terminology related to the idea of justice; and situating his theory of justice as fairness with respect to prior social-contract theories as well as other types of theories of justice.
