writing - How to Refer to Enumerated Subsections and ...

(1) The highest subdivision within a rule is a "subsection." You need not subdivide below this level. (A) When there are two or more subsections, designate them with a lowercase letter in parenthesis. Example: (a), (b), etc. (B) When there is only one subsection in a section, omit the "(a)." This is referred to as an "implied (a)."
