APA citation basics When using APA format, follow the author-date method of in-text citation. This means that the author's last name and the year of publication for the source should appear in the text, like, for example, (Jones, 1998). One complete reference for each source should appear in the reference list at the end of the paper.

Reference list citation components. All references sit together on their own page, which is usually the last page (s) of a paper. Title the page 'References'. Place 'References' in the center of the page and bold it. Keep the title in the same font and size as the references. Do not italicize, ...

If the source you are citing is a standalone source, meaning an entire book, television series, or film, the title of such sources should be in italics. If, however, you are citing a piece of a larger source, i.e., a journal article, a page on a site, or an episode of a show, the title should be in sentence case and not in italics.

Basic book citation format The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).
