For a number of the major sports leagues in the United States, a standard player contract (a form agreement signed by each player in the league) and the CBA that governs it, together contain the contractual terms that address (directly or indirectly) the payment of player salaries both generally and in connection with potential game cancellations or suspensions due to acts beyond the control of the parties—typically in the form of “force majeure” language.

Collective Bargaining, Professional Sports, and COVID-19 ...

Feb. 28, 1968 - Owners and players reach the first collective bargaining agreement in professional sports history and the first to provide for a minimum Major League salary. The Basic Agreement limits the power of owners to unilaterally establish or change rules governing the industry, requiring most changes to be agreed upon by owners and players as a result of collective bargaining.
