Actions for divorce in Scotland may be brought in either the Sheriff Court or the Court of Session. In practice, it is only actions in which unusually large sums of money are in dispute, or with an international element, that are raised in the Court of Session. In more complex cases the appeal could be heard by a bench of three appeal sheriffs in the Sheriff Appeal Court in Edinburgh. The sheriff court has exclusive jurisdiction to hear cases worth up to £ 100,000. Examples of civil cases the sheriff court can deal with are: separation, divorce or dissolution of a civil partnership; custody or aliment disputes
