The local authority can start ‘care proceedings’ if they are worried about a child and can apply to the Family Court for a care order. They can also apply for a placement order if they believe a child cannot safely be returned to his/her parents or other family members, and should be adopted.

Private fostering is an arrangement whereby a child under the age of 16 (or 18 if the child has a disability) (S.66 Children Act 1989) is placed for 28 days or more in the care of someone who is not the child’s parent(s) or a ‘connected person’.
