A notary public is a public official appointed by a state government to help deter fraud. Notary publics witness the signing of important documents and verify the identity of the signer(s), their willingness to sign the documents, and their awareness of the contents of the document or transaction.

What is a Notary Public?

A Notary is a qualified lawyer - a member of the third and oldest branch of the legal profession in the United Kingdom. Notaries are appointed by the Court of Faculties of the Archbishop of Canterbury and are subject to regulation by the Master of the Faculties. The rules which affect Notaries are very similar to the rules which affect Solicitors.

An applicant for a notary public commission must submit to the Division of Licensing Services an original application and \$60 fee. The application includes an oath of office, which must be sworn and notarized. In addition to the application form and fee, the applicant must have taken and passed the notary public examination.
