-Notary fees are not public funds, thus not subject to reporting to or auditing by state legislative auditor-Occupational licenses and self-employment taxes: Notary fees are exempt from occupational license tax and self-employment tax. Also, because notaries are state officers, they are not required to have further licensure by local governments.
