The Illinois Department of Agriculture and the University of Illinois Extension provide training and testing for anyone wanting to obtain an Illinois private pesticide applicator's license. The fee for a private pesticide applicator license is \$30.

Private Pesticide Applicator Training and Testing - Illinois

Illinois law requires that Commercial and Commercial Not-for-Hire applicators and operators pass (with a score of 70% correct or better) a written, closed book General Standards exam. Applicators must also pass one or more category exams appropriate for the sites to which they apply pesticides. Licenses are valid for 3 years.
