Michigan Legislature - Act 23 of 1993

The Michigan Limited Liability Company Act sets out particular activities, which in and of themselves do not constitute transacting business. In determining whether it is necessary to obtain a Certificate of Authority, the limited liability company should look at its proposed activities in this state, the statute, and applicable court decisions.

Michigan LLC Law, also referred to as the Michigan Limited Liability Company Act was passed in 1993. It created a new kind of business entity offering business owners a strong degree of personal liability protection, as they would have with a corporation, but with flexibility in management and pass-through taxation like a sole proprietorship or partnership .
