Medical and dental offices are currently exempt from maintaining an official log of reportable injuries and illnesses (OSHA Form 300) under the federal OSHA recordkeeping rule, although they may be required to maintain records in some state plan states. If you are in a state plan state, contact your state plan directly for more information.

OSHA guidelines require medical offices to provide employees with information regarding any hazards that are present: Hazardous chemicals used and/or stored in the medical office (a copy of the Material Safety Data Sheet should be provided)

OSHA guidelines for medical offices require a written exposure control plan. An exposure control plan is a written document that includes a list of employees who may be exposed to bloodborne pathogens in the course of their work.

Reply: When there is occupational exposure to blood or other potentially infectious materials (OPIM), the OSHA bloodborne pathogens standard, 29 CFR 1910.1030, requires the employer to provide, at no cost to the employee, APPROPRIATE personal protective equipment such as, but not limited to, gloves, gowns, eye protection, shoe covers, laboratory coats, or other equipment deemed necessary [See 29 CFR 1910.1030 (d) (3) (i)].

The OSHA website also offers specific guidelines for working positions designed to prevent muscle strain and musculoskeletal disorders commonly associated with office work. OSHA recommends that workers who work in a seated position for long periods should attempt to maintain a neutral position to avoid these health and safety issues.

OSHA's regulation, "Access to Employee Exposure and Medical Records" (29 CFR 1910.1020), requires the retention of occupational medical records for 30 years after termination of a worker for the purpose of providing access to the records for employees and their representatives after a worker has left employment.
