Formatting Basics The reference list should start on a separate page at the end of your paper. Use one-inch margins and continue the header from the rest of your paper. Title the page References, centered at the top (no bold, italics, quotation marks, etc.). References should be in a hanging indent ...

How to Cite a Research Paper: APA, MLA, and Chicago ...

Start a new page for your Reference list. Centre the title, References, at the top of the page. Double-space the list. Start the first line of each reference at the left margin; indent each subsequent line five spaces (a hanging indent). Put your list in alphabetical order. Alphabetize the list by the first word in the reference.

References and the Citation Format for a Research Paper It is crucial to be aware of important things about formatting when performing your paperwork such as a research paper or an essay. Analysis work should contain from eight to ten pages. The selected format of references in a research paper determines how to order them in one ' s paperwork.

The reference page is also called the annotated bibliography, and it should go at the end of the research paper. The purpose of annotated bibliographies is to link each source to one another in an orderly fashion. Here are six key factors for writing an annotation:

Track which sources you actually use. Typically, you will only include the resources you actually cited or paraphrased in your paper on your reference page. Therefore it's important to make a note of which references you actually cite within your paper and which references you merely use for background reading.

List the title of the research paper. Use sentence capitalization to write out the full title of the research paper, capitalizing the first word and any proper names. If it has a subtitle, place a colon and capitalize the first word of the subtitle. For example: "Kringle, K., & Frost, J. (2012).

When citing a reference from your reference list, please use the following conventions. Put in parentheses the author(s) last names, the year, and optionally the page number(s) separated by commas. For one author, use the author's last name and year separated by a comma. For example: (Walters, 1994) or (Austin, 1996).

Citation management tools allow a user to organize and retrieve information, such as citations for books, articles, and Web sites, by interfacing with library databases. The citation manager then works with word-processing software to insert properly formatted footnotes or citations into a paper and create a properly formatted bibliography.

MLA research paper format requires that the entire research paper or MLA format essay includes double-spaced lines. Double-spaced lines should be found in between the written body of the work, in the heading, and also on the MLA reference page.

In APA style, in-text citations are frequently utilized. Such citations are placed in parentheses with the author's name and year of their work ' s publication. This information must match what you provide in the reference list at the end of the paper. The reference list or bibliography should be formatted in the following manner:
