If you write a research paper in MLA format, then you will need to include a Works Cited page (sometimes referred to as an MLA bibliography) according to the current edition of the Modern Language Association (MLA) guidelines.

A bibliography is an alphabetized list of all the sources used in the paper. This list is found at the end of the work and allows the reader to verify the veracity of the statements and/or figures presented in the essay. It also allows a writer to give proper credit for quotes or key phrases so as to avoid plagiarism.

There are standards for documenting sources of information in research papers. Even though different journals may use a slightly different format for the bibliography, they all contain the same basic information. The most basic information that each reference should have is the author's name, the title, the date, and the source.

The purpose of annotated bibliographies is to link each source to one another in an orderly fashion. Here are six key factors for writing an annotation:
