The 1992 Guidelines were revised in 1997, almost concurrently with the FTC's challenge of the Staples - Office Depot merger in federal court. The 1997 Horizontal Merger Guidelines were replaced on August 19, 2010. These guidelines introduced the concept of "upward pricing pressure" resulting from a merger between competing firms.
